



# The EU's Anti-Poverty Strategy: An evaluation and next steps

The **President Von der Leyen's** political guidelines for 2024-2029 announced the first-ever European Anti-poverty strategy to help people to get access to the essential protections and services they need, along with addressing the root causes of poverty.

The Strategy is expected to be presented in 2026. To prepare it, the **European Commission (DG EMPL)** and **Bocconi University** are organizing a joint event to gather expert contributions, focusing on topics such as minimum income, breaking the intergenerational transmission of poverty, and financing anti-poverty measures

The event will also contribute to the preparations of the **World Social Summit**, taking place in Doha on 4-6 November.
